## Highlights in 2017

### Products:

ATG implemented Grand Slam 75 (GS75) on Sundays in the first half of 2017. Grand Slam 75 is a variation of V75 always arranged on Sundays.

V75 Winter Burst was held in the end of 2017. Eight V75-meetings in nine days with a final super jackpot on New Year's Eve.

### Legal situation:

The study of a new gambling legislation was presented by the state investigator on March 31<sup>st</sup> 2017. In the proposal for a new gambling law is included to open up betting on horseracing in a licensing system. The Swedish Parliament is planned to decide for the new gambling law in May and the new law is proposed to be implemented from January 1<sup>st</sup> 2019.

### Others:

ATG have made a conditional acquisition of the Danish betting company Ecosys A/S. The condition is that the new legislation which is planned to start 2019 will allow the agreement.

Decision of a new record in distribution of funds to the horseracing industry. ATG has followed the plan from 2014 and has decided to raise the distribution 2018 with ca 300 million SEK (30 million €) to 2 billion SEK (200 million €) which is a new record in ATG history.

ATG has started "Drömfonden" (The fund of Dreams) with the famous ice hockey player Peter Forsberg as an ambassador. The Fund of Dreams will distribute funds for organizations whose dreams can be a reality.
